Director's Update

Welcome back to term 4! Term 4 looks to be another very busy term with children and staff learning and playing right up until the 22nd of December. That's right, we are open during the week after the school year ends (Should we say "Vacation care is available in this week")i.e. from Monday 18th - Friday 22nd Dec. Our Summer VC program will be out by Friday 24th Nov.

Centre Assessment and Rating Visit

During the Winter VC, we were assessed by ECEC. Our Centre was assessed against the 7 quality areas of the National Quality Standard (NQS) and was given an overall rating based on these results.

The visiting inspector engaged with the staff and children attending on the day and scrutinised at the documentation from all 7 quality areas. The result of the visit was sent to us on 10th October 2017. Truscott St OOSH now have an overall rating of **Exceeding the national quality standards.** This rating was a team effort and an excellent start for all the good things to come in the future.



Re-Enrolment Notice Re-enrolments for 2018 have begun. **Please remember there are two parts to the reenrolment process.** First is to make sure all your details e.g. address, contact detail of both parents and guardians is up to date and that all medical conditions are updated in the system. The second part of reenrolment is to make the nescessary bookings. Your bookings will only be confirmed if you add them during the reenrolment process. You should get a booking sheet at the end of your re-enrolment confirmation email. It should have the days you have booked listed in it with a TBC written next to them. The official booking confirmation will be sent out by mid T4.

Any new siblings starting school in 2018 can be added to the **Add Child** section in the Becklyn portal during re-enrolment.

Update Medical Conditions

Please advise OOSH of any new, ceased or other changes to your child/ren's medical condition or

prescription. The OOSH office will require an updated individual medical management plan from the child's medical practitioner or specialist detailing the medical condition of the child, correct dosage of any medication as prescribed and how the condition is to be managed in the service environment. We need to have updated information to support children with medical conditions to participate fully in the day to day program.



Revised National Quality Standard (NQS)

From the 1st October 2017, changes to the National Law and Regulations will commence. To ensure the delivery of early childhood education and care services nationally continues to improve in the most efficient and effective way.
